APPLICATION PROCEDURE

Traineeship mobility is possible in EU member countries and third countries associated to the Programme (North Macedonia, Norway, Iceland, Liechtenstein and Republic of Türkiye).

Students should (by themselves) find an academic partner (university abroad) or non-academic partner (hospital, company related to the medical field) from any of the aforementioned EU or third country, which can offer the possibility for Erasmus traineeship and issue relevant Acceptance Letter to the student.

Please complete your application folder, name it properly (e.g., your name_desired university_erasmus), zip and send to the above email until the indicated deadline.

Your application folder must contain the following documents – pdf or word files (incomplete applications will not be considered!!):

- ✓ Application form UNS for students ERASMUS+ ([download](#))
- ✓ Passport copy (first page)
- ✓ Motivation letter in English (1-2 pages)
- ✓ Student's CV (including address, contact phone number, email and photograph)
Recommended form: *Europass* model ([download](#))
- ✓ *Transcript of Records* in Serbian and English (you can obtain it in the student secretariat)
- ✓ Language skill proof - certificate

- ✓ Draft of Traineeship Agreement for students ([download](#)) – fill out the **BEFORE MOBILITY section**
- ✓ Acceptance Letter of the host institution

- Candidates can send only one application
- Final decision on selected candidates is made by the Erasmus+ Committee of the University of Novi Sad upon the proposal of the Erasmus+ Committee of the Faculty of Medicine Novi Sad

ONLINE LINGUISTIC SUPPORT (OLS) is a portal known as [EU Academy](#) for testing the language skills of students selected for Erasmus+ mobility at partner institutions abroad and for attending language courses during the mobility. OLS is applicable only for mobilities where the language of mobility (teaching or traineeship) available at the platform – excluding native speakers (native speakers are not tested if the mobility is conducted in their mother tongue, but they can attend and be tested in other foreign language, e.g. English).
